At 7:02 p.m. Sunday, April 21, 2013, the UC Merced Police Department received a call of a disturbance in the housing area.

Officers determined one person suffered a stab wound and was taken to an area hospital. Officers have detained two people and are questioning them in connection with the stabbing.

According to the most current information, no UC Merced students have been or are involved in the incident. Officers believe this is an isolated incident with no continuing threat to the campus community.

The investigation is ongoing and may take several hours; officers ask that people avoid the walkways in and around the Summits and Valley Terrace areas.

If you need to access those areas please contact the police department for assistance. Also, please follow directions of the police officers and community service officers at the scene.

Updates will be provided to the campus community as they become available and are pertinent to campus safety. We thank you for your continued support and cooperation.
